## Assessment Guidance:

1.1 A specific selection of devices should be provided.

*1.4 and 1.5* Assessment could be in the form of a specific scenario, such as setting up a unique wireless access point, or a standalone network connection.

2.3 Potential evidence could include witness testimonies and supporting screenshots provided by the learner.

2.5 Suggested evidence production of user guide. Scenario provided should include guidance on the audience, which will impact on the language and technical terminology used.

*3.1, 3.2 and 3.3* Assessment could include providing specific requirements to aid the selection of search techniques. Searching techniques to narrow the responses could include:

- Explicit phrasing
- Exclusion of words
- Words in a title
- Specified file types

3.4 Use of academic referencing techniques may be appropriate in some contexts.

*4.2 and 4.3 Use* online file sharing tools to work collaboratively on a single document. Evidencing of this could take the form of a witness testimony in conjunction with supporting screenshots.

*5.1* A minimum of two threats should be evaluated for user safety and two for transmission of information.

5.7 To include consequences to the individual and the organisation These could include:

- Criminal record and possible impact on future employment
- Fines and other legal penalties
- DDoS attacks
- Hacktivist activities.

*LO 5 Assessment activity* could take the form of a presentation of findings relating to threats, personal online safety and security practices, online offences and laws. This could be tailored to meet the needs of a specific audience. Evidence could be a recording of the presentation, witness testimonies and any additional notes that were prepared when planning for the presentation etc.
